WEDDING POLICY

With Hayley Taylor's abundant years of experience, she will create breathtaking up-dos to help make your wedding day beautiful. All services are priced accordingly to your needs and include the use of professional hair products and supplies. The rate does not include the cost of travel, head pieces, hair accessories, and flowers. These items will be negotiated separately.

1. **Complimentary Consultation:** Here we will discuss your hair needs and schedule a practice run and wedding day services. Our contract and cancellation policies will be reviewed and a 50% deposit for all services will be collected. Since summer and holiday weekend dates are always in short supply, we recommend you book your wedding services at least 4 months in advance.
2. **Practice Run for the Bride:** This should be scheduled 3 to 4 weeks prior to your wedding. Bring everything you'll wear in your hair on your big day, such as your veil, jewelry, and so on. A picture of your dress is a plus when helping make decisions for the look of hair as well as a few pictures of hair styles you prefer. Please view this as your wedding day trial run. Practice runs with Brides are **required**.

3. **Wedding Day Hair:** I'll recreate the look we achieved during your practice run. Please remember that everyone in your wedding party is welcome to join us for services on your wedding day.

- Bride Up-do \$100.00
- Bridal Party Style \$75.00
- Blow Dry \$45.00 and up
- Braids (no other styling) \$25
- Extensions (clip in) Consult needed

Please note that wedding party prices are per person, per service.

4. **Off Site Travel Fees:** For those who need me to travel to their location, please schedule wedding services at least two months in advance. Travel fees are in addition to our regular service cost and will be discussed on above form:

Stylist needs a designated space to set up when on location. The bride is responsible for clearing an area before the stylist arrives. The stylist will need a work area with a chair near an outlet in a no walk-through traffic area. Good light and a mirror is a plus. If services cannot be performed due to insufficient work conditions or tardiness, all fees still apply. The hair stylist will not be held liable for any injuries that should arise while on location.

IMPORTANT INFORMATION FOR YOUR BRIDAL SERVICES

To help us serve you better and ensure that your wedding day runs smoothly, we ask that you and your wedding party please follow these simple guidelines:

- Please arrive with clean, dry hair to help the hold of the hair style. Please do not put product or use a flat iron prior to arriving for your appointment. An additional fee may apply if you request a wash and blow dry or straightening. An additional fee will apply if anyone shows up to their appointment time with wet hair (blow dry fee plus up-styling)
- During your trial run, please wear pants/skirt and an ivory or white shirt that is as close as possible to the color of your wedding dress to ensure that the look suits your vision.
- Bring pictures of different hairstyles that you are interested in for the hair stylist to view.
- Please bring in your headpiece, veil, and any hair accessories to try on at the trial as well as bringing them with you the day of your wedding if you prefer the hairstylist to place said head piece.
- On the day of your wedding, you are invited to bring in any drink or food that you feel will make your day more special. I do offer complimentary coffee and water, but feel free to bring in a more personalized selection.
- On the day of your wedding I ask for you and your bridal party to be dressed in either a zip or button up shirt. You would not want to have to pull your clothes over your head after your hair and makeup is done perfectly.
- For your wedding day I can operate before normal business hours for your convenience. A fee of \$120 per person before 8:00 am.
- Most importantly, please be on time for your wedding day appointments. Even starting 15 minutes late will put everyone behind and we don't want you to be late for your special day!

I understand and agree to the non-refundable deposit of \$100 at this time to secure the appointments and wedding date. I agree to pay 50% as your pre-payment at the day or your Practice Run. I understand that no refund will be given for a member of the wedding party who misses their appointment on the day of the event.
